- 1. After the fees payment, students are requested to submit the Examination registration form after duly filling the required details.
- 2. Students are advised to submit the forms personally and not to entrust the job to any other student on their behalf.
- 3. The students are here by instructed that, submission of the registration forms for the above examinations is mandatory on or before the stipulated last date.
- 4. Registration forms for above examinations will be accepted from the students who have cleared all their dues.
- 5. Date of submission of filled Registration form is the basis for charging the fine not the date of payment of examination fees.
- 6. Hall Tickets will be issued only to the eligible students who fulfill the academic requirements of the University. The students are informed to note that mere payment of examination fee does not guarantee eligibility for appearing for examination.
