Note:

1. The students are requested to pay the exam registration fees for the above exams at VCET Office as per the fees structure mentioned.
2. After the fees payment, students are requested to submit the Examination registration form after duly filling the required details.
3. Students are advised to submit the forms personally and not to entrust the job to any other student on their behalf.
4. The students are here by instructed that, submission of the registration forms for the above examinations is mandatory on or before the stipulated last date.
5. Registration forms for above examinations will be accepted from the students who have cleared all their dues.
6. *Date of submission of filled Registration form is the basis for charging the fine not the date of payment of examination fees.*
7. Hall Tickets will be issued only to the eligible students who fulfill the academic requirements of the University. The students are informed to note that mere payment of examination fee does not guarantee eligibility for appearing for examination.
8. The students are required to produce fee payment receipt while collecting the Hall Ticket.
9. For the students applied for RC/RV, if the results are not declared by the time of start of registrations for exams, the students are advised to register as per the time schedule given in this notification even for the subjects in which they have failed and waiting for RC/RV results. However, if the student passes the examination in RC/RV results, the examination fee paid for passed subjects will be refunded by the concerned examination In-charge and the registrations of the student in that subject will be automatically deleted.
